



# CSOC Summer Camp Services 2022: A Guide For Families

## Deadline

Completed applications for both Financial Support toward Summer Camp Tuition and One-to-One Aide Services for Summer Camp must be postmarked or received by PerformCare no later than **June 30th 2022**. Applications, including supporting documentation, **MUST** be complete in order to be considered. It is the responsibility of the applicant to ensure all necessary paperwork is on time.

Important Information
Financial Support toward Summer Camp Tuition is for the camp's daily rate, not to exceed \$80.00 per day for day camp (for a maximum of 10 days) and not to exceed \$133.00 per day for overnight camp (for a maximum of 6 nights). Parents or guardians are responsible for the cost of summer camp not covered by CSOC.
<b>You will also need the youth's CYBER ID number in order to complete the application. If this information is not known, please contact PerformCare at 1-877-652-7624.</b>
When an eligibility determination for Financial Support toward Summer Camp has been made, PerformCare will provide written notification of the decision's outcome to the family and camp within 30 days. Notices will be mailed after April 30th 2022.
