- Copy of birth certificate, if new
- Copy of annual income tax statement or W-2 form, TANF and/or SSI check, current year
- Copy of child's cover page and evaluation stating diagnosis from the IEP for current year.

You must include proof/copies of income for **all people living in the household**, no matter the relation to the camper. Failure to do so will result in ineligibility for an award.

Once you receive notification verifying your award, **you must contact the camp/program to secure placement. PCIL does not register individuals for camp.**

## Campership Award Program

The County of Mercer, NJ awards funds to its residents ages 4 to 25 who have a disability to attend a summer program/camp of their choice from Memorial Day through Labor Day.

The 2019 Camp Scholarships will be awarded on a **first come - first serve basis**. The amount of the award is dependent upon annual household



income and the total members living in the household.

## Questions to ask the Camp Director

Before enrolling a child in a summer camp program, parents should ask the camp director the following questions:



- √ What is the ratio of campers and counselors?
- √ What percentage of campers and staff return to the camp each year?
- √ How is staff screened? Are references checked for all staff having access to children, including aides and drivers?
- √ What is a typical day like; is it structured?
- √ How will the camp deal with the specific needs of my child?
- √ How is medication distributed and by whom?
- √ What type of medical insurance does the camp carry?
- √ Ask for a typical menu. Is there a snack area/cafeteria?



- √ If a mainstreamed camp, have they had children with disabilities before? How was the situation handled and was it successful?
- √ Ask for the location of the local hospital.
- √ Who does my child go to if he or she has a problem with his or her counselor?
- √ What is the camp's refund policy?
- √ If the children will be picked up by a bus or van, will there be someone other than the driver to provide supervision?
- √ What is the policy regarding who can get onto the campgrounds?
- √ What is the policy about picking up and dropping off children? Can any one pick up my child without my permission?
